EXECUTIVE COMMITTEE REPORTS

CHAIRPERSON - Good Morning Area, I'm an addict called Donna. Welcome to Area...thanks for suiting up, showing up, and participating in your recovery as well as representing your groups and subcommittees here today. I have wonderful, and sad, news creating mixed emotions for me. I have been offered and accepted a position in Olympia, Washington. I will be moving the middle of December and starting my new job on January 2, 2007. One of the miracles of recovery is becoming a responsible, productive member of society. I am officially submitting my resignation for the EASC Chairperson's position. I can, without a doubt, say that a huge part of this is your fault. If you hadn't accepted and loved me when I couldn't love myself I would never have grown into the recovering addict I am today. Page 102 of the Basic Text says "If we had written down our list of expectations when we came to the program, we would have been cheating ourselves." The life I have today is nothing like my life before recovery in NA. Since coming into recovery, people and situations seem to appear at just the right moment, creating just the right experience and skills, guiding me towards just the right thing for my life. I believe my awareness of these people and situations is directly related to my relationship with my Higher Power, a relationship I owe to NA. When I listen to the message instead of getting caught up in judgment about the messenger, I am always shown my "next right step". Some of you may know Washington is where my daughter and grandsons live. Because of this program, I now have the opportunity to be part of their life on a daily basis rather than a "once every two-month" basis. Page 100 in the Basic Text says "We can enjoy our families in a new way and may become a credit to them instead of an embarrassment or a burden. They can be proud of us today... It gives us good feelings to know that aside from our value to others as recovering addicts, we are also of value as human beings." Next month would be my six-year anniversary of arriving in Eugene. I showed up, unknown to anyone, saying I had almost six years clean and wanting to get involved with service. After about six months, I came to my first Eugene Area Service meeting as a GSR for my home group. I remember being part of a discussion about EASC by-laws, major motions, procedures, and offering to help with rewriting the by-laws, as I had worked on by-laws in Oklahoma at both area and regional level. I was told at the time I wasn't qualified to participate in that function as I was new to area and didn't know how things worked here in Eugene. That really upset me... didn't they know who I was? But I just kept coming back...it may surprise some of you to know I have a defiant streak. Almost two years later, I worked with Cathy K and Gerry M to rewrite and update the EASC by-laws. Did I mention Cathy was the vice chair who told me I wasn't qualified to participate? So much has happened here at the EASC since that first meeting. Our business meetings have been fine-tuned and streamlined and the EASC runs like a well-oiled machine... I was blessed to follow my predecessor, who spearheaded a lot of those changes. Don't get me wrong... we still have to face difficulties as they arise: communication problems, differences of opinion, internal controversies, and troubles with individuals and groups outside the Fellowship (as it states on page 58 of the Basic Text). We have done all those things and more. I want to say I am truly grateful for being allowed to be part of the Eugene area. I have participated here as a GSR, an Ad-Hoc committee member, EASC Vice Chair and EASC Chairperson. I have experienced a lot of growth during my six-years in the Eugene area. I am deeply indebted to y'all for being part of that experience. Thank you for letting me be human and forgiving me when I made mistakes or had an error in judgment. Thank you for letting me be of service to the Eugene Area and to NA as a whole. I also want to tell you that if no one has told you today they love you... I do and there's nothing you can do about it. In loving service, Donna P. P.S. You may be surprised when I show up at area in the future...just to say hi. I have lots of friends here and I'm not going that far away.
