REGIONAL COMMITTEE MEMBER (RCM) –

Hello Family,

First and foremost I would like to thank everyone that showed up and participated in the Region Assembly. It was a great success.

Attached is the Expense Report from the Planning Committee Ad-Hoc. Thank you all for your support and participation, we were fully

self-supporting and had an amazing turnout for the workshops.

Following are my notes from Region business on Sunday:

Chair – has emailed a copy of the Region Inventory Outline and Questionnaire. She has asked that those of us that participate at Area service review and answer the questions. Because this is an inventory about how our Region fulfills its responsibilities to the Areas, it is not necessary for it to be returned to homegroups.

GSR's, Executive Committee members and Sub-committee Chairs should be able to answer the questions as they pertain to them and return the questionnaire to me. I will include the Questionnaire and Outline as an attachment to the secretary to include with the minutes.

In addition, news from NAWS is that we can participate in upcoming literature by getting onto the NAWS website and looking for the links to "Service System – Good practices" where we share about the positive service practices that have helped us to better serve the still suffering addict. Also, new literature coming out – they are looking for input – it is called "Living Clean."

Vice Chair – Please call him for support and as a resource for Sub-committees or Areas. Otherwise – No Report.

Treasurer – Checkbook is balanced. The PCRCNA committee submitted their budget and the PNW committee turned in their hotel contract. After forwarding our Region Donation to NAWS of \$734.47 we had a starting bank balance of \$8,309.75.

I will be submitting a copy of the proposed budget to be included in the minutes, this will include three attachments – Proposed Budget, Current Budget and an Actual vs Budget report for the past fiscal year. This budget will be voted on at the April RSC. Please take back to your homegroups and we will vote at our April ASC.

Secretary – Work in process – she is learning rapidly – please submit written reports or email to her.

RD (Regional Delegate) – Great Assembly and workshops. March 1 – May 30 literature will be submitted for review and approval.

There was discussion about World funding the RD travel to Forums. Has cost NAWS a lot of money and donations from Regions to help offset costs have not been enough. New website will be handled in parts. She requested her travel funds for the Word workshop in California from 2/27 – 3/1.

Alt RD – Traveled with the RD to facilitate the "Building Strong Homegroups" workshop in Central Oregon and it was a great success as was the workshops yesterday.

Activities – Event merchandise that was returned was distributed per existing guidelines. New Activities guidelines are being submitted today.

Archivist – receiving more boxes of archive information from a local member and will be scanning information to put on a zip drive so that she can have all of the information available at future RSC's. It will take time.

Conferences & Conventions – No bids for upcoming 2010 PCRCNA XVII. Upcoming April RSC and H&I/PI Learning Days will be held in Medford on April 18 & 19. July RSC and Assembly to be held in Coos Bay and October is possibly in North Coast. Logo deadline for upcoming PNW 33 hosted by our Region (2011) is July 1, 2009. Topic is "No Matter What" full registration package (no hotel). Asking for the Region to look into purchasing a credit card machine for Region events.

Lit Chair – She sent her regrets and a resignation letter. 3 areas were represented and discussed Area Lit committees and how to increase attendance at Region. Also want input from the fellowship on the current Literature project "Living Clean".

H & I – They have been planning the afternoon portion of the Learning Days in Medford in April. Our region has 200+ commitments being met around the state. Due to budget cuts the meetings in Jefferson County have been closed. Mid Willamette Valley has their H & I subcommittee up and running again and doing well.

PI – They have been planning the morning portion of the April Learning Days. WSLD was a success with a huge round table discussion that was not on the schedule but was well attended. The Head of the State prison system was present along with 75-80 other professionals. Due to possible controversy regarding possible litigation about posting the MP3 files on a public access website, the PI subcommittee purchased the CD version of the WSLD this year and have removed last year's MP3 files from our website. You can contact the PI Chair to check out any of that information. Their goal is to archive that information and let individual areas check it out for use. They have been putting together a Yahoo group forum to assist in Inter-Region communication. PI Subcommittee would like to know if our Region is interested in hosting WSLD 2011.

Motions: - Available funds \$2586.75

MM#1 – Bring RD approved travel fund accrual to full. Cost \$550 Under the Budget line item “Any World Services Travel there is an \$1100 annual accrual. Because we forwarded on the travel funds to NAWs according to our guidelines to help offset world’s cost of funding RD travel the current accrual is down to \$550. we are two quarters behind. Because the RD & Alt RD have requested their travel funds to go to California next month we need to fill the accrual. Passed 13-0-0

MM#2 -HI – requesting Seed money of \$150, to assist in the purchase of flyers, facility rental and coffee for the upcoming Learning Days. Passed 13-0-0

MM#3 - Requesting travel funds to offset travel expenses for the Web host to come to today’s region. Up to \$45. Passed 13-0-0

MM#4 -\$75 for treasurer to order more checks. Passed 13-0-0.

MM#5 -C&C requesting fund up to \$200 to purchase new walkie talkies and batteries for the region, to replace old and worn out equipment. Passed 12-0-1.

Major Motions:

M#1 Tim A – motion to remove outdated Major Motions from the Major Motions page in the Region guidelines, motions # 8,9,10,12 & 14. Housekeeping. Passed 13-0-0.

M#2 – Form a Bid Proposal to host the WSLD 2011. in Oct or Nov. Bid proposal to be presented and at April and voted on either then or in July. Passed 13-0-0.

Business went well and we were pleased to welcome North Coast back at region – they had not been present in a while.

INSURANCE AD HOC –

Lane County Area Service,

The committee has met once since area. We invited an Independent Agent who serves on a couple of Non-Profit Agencies to assist us with our initial review.

Area's of discussion and discovery of our current policy:

- there is no coverage in effect for any group meetings
 - o due to the structure of NA, insurance would need to be purchased by each group individually if they desire any liability coverage.
- there is no coverage at any event for childcare of any sort. Any childcare would need to be handled by a licensed, bonded and insured service to have liability coverage for a facility at an event put on by NA.
- there is really no coverage for "members of NA" at our meetings and events. The only coverage listed is for the facility and "guests", with a caveat, that there might be up to \$5000 to cover a member.
- there is only coverage for 13 "meetings/gatherings" per year as listed in our current policy. By our count there are over 130 that should be covered by this insurance as it is written.
 - o Area Service
 - o Executive Committee
 - o The Sub-Committee meeting held out side of a members home
 - o All events
 - Picnics
 - Dances
 - Retreats

The insurance policy costs are based upon the number of meetings, the types of meetings and events needed to be covered and the average number of attendees at the meetings.

These are our findings. We plan to meet in three weeks after we have obtained proposals for new coverage. If the Sub Committee Chairs could tell me in the next week (I will be calling you), an estimate of how many people attend the Sub Committee meetings, and other than the monthly meeting, how many “other events” their committee might hold and the average attendance. We hope to have something for the March Area Service meeting.
