INSURANCE AD HOC – March 7, 2009 Lane County Area NA,

The Insurance Ad Hoc Committee has completed our inquiry. We have found the current insurance policy to be a liability for Area. It does not cover our needs, or our fellowship. We have received a proposal that we believe will meet our needs. This plan will cover:

- All Activities sponsored events as well as any Area sponsored events. This also includes sub-committee meetings and events held in public places.
- Maximum coverage will be \$2,000,000 per event. \$1,000,000 per claim.
- Plan will cover members and guests at the events.
- Designed for "Not for Profit" entities.
- NA does not need to have a physical office (we can operate from the PO Box).
- The cost is \$1091 per year. \$362 down, with the balance billed over 8 months.
- SAFECO should refund Area the unused premiums on our current policy. We believe this amount to be approximately \$150.

We make a recommendation to the Executive Committee to hold an Emergency Session following area to implement this policy.
