**P.R./HELPLINE** - Greetings! I'd like to start by saying that I'm honored and excited to be given the opportunity to Chair PI in the Lane Co. Area! Although we are small in numbers, we have a great group committed to furthering our primary purpose. That being said, we have several open positions currently on PI. We are in need of both a Vice Chair and Booth Coordinator and could also use a few extra committee members to help with several new projects we will be working on over the next year.

I was able to attend both Learning Day and Region last month. We were fortunate to have NAWS members there to do a workshop

related to effective presentations for PR and H&I, as well as, some of our differences and strengths within our community. One other take away from the weekend was a potential joint event hosted by our H&I and PI committees...more on this to come! Most pressing right now is the Booth Coordinator position, given the return of the sun; the clean time requirement for this position is 1 year. I do have a couple of volunteers willing to sit in the booth once we decide on the frequency we will be at Saturday Market,

however we really need help in this area.

We are continuing to evaluate the options to improve our Helpline. Currently, we are looking at the cost effectiveness of using a virtual PBX system. This would not only allow for calls to be forwarded directly to a volunteer's personal phone, but provide up to 10 mailboxes/extensions for meeting schedules, sub-committees, events, etc. Several other areas throughout California, as well as other states, are currently using the company we are evaluating. Given that they have worked with many other NA Helplines, there is a basic format available. Our current cost for our Helpline is approximately \$110 per month; the estimated cost for a virtual PBX system is approximately \$40. We potentially could save several hundred dollars annually. Currently, we have a single physical phone carried by, literally, the same one or two volunteers; a virtual PBX system would allow for more ease of volunteer participation with direct call forwarding. I hope to have a complete cost comparison, with all the plan details next month. If anyone is interested in evaluating the systems currently in use by other areas, see me after the meeting for a list of their Helpline numbers.

I would also like to ask that this Area consider allowing PI to become more in line with World Services by starting the process of changing our Sub-committee name to Public Relations. This does not mean jumping into an umbrella structure, combining our sub-committees as one. It simple means we have made a conscious decision to validate the World Services vision statement, "to work

together in a spirit of unity and cooperation to carry our message of recovery" and, from the PR Handbook:

"For our purposes in Narcotics Anonymous, the term "public relations" refers to all of the relationships we create and maintain with the general public, professionals, potential members, and each other in our groups and service communities. We have been establishing relationships with the public all along, whether we have made a choice to be aware of and participate in those relationships or not. It is time to look more closely at how we relate to the rest of society as well as to fellow members. It is time to gather our collective experience, and improve our service efforts so NA can continue to become a more reliable and recognizable program of recovery." (CH 2 pg. 3, PR Handbook)

With that statement in mind, this committee will also actively begin working on starting a Newcomer Workshop in this area. This concept allows for basic information about NA to be presented in a format that allows for questions and active participation by the newcomer or any other interested person. If anyone would like to be a part of this project, see me after the meeting.

Also with that statement in mind, I believe that as Sub-committees serving this area, we have a responsibility to be consistent and accountable to our members, whether this means adhering to our guidelines, producing inventories or showing up for meetings and events at the time they are posted.
