**PR/HELPLINE** – Greetings!

I'm writing this report to address the concerns regarding a point of accountability for the PR Committee. As I mentioned in reports to this body in both February and April, I would not be available to consistently attend ASC due to my work schedule; however, I had no intentions in decreasing my participation on the PR Committee. I also mentioned that I was available to continue with all projects the PR Committee had in progress, including the Intro to NA Workshop.

This type of service is not for everyone. While there are many “behind the scenes” positions on PR, public speaking is not one of them...you must be willing to expose yourself as a member of Narcotics Anonymous, losing your anonymity. I feel that it is important to maintain a point of contact for this committee that can interact with the public, including the ability to address any professional component of our community that may have an interest in NA as a fellowship. Because this committee has established many professional relationships over the last several years, including a newly established relationship with the Drug Court, and our recent mailing that includes all of my contact information, I would like to respectfully request that this body consider my continued participation as a “point of accountability” for the PR Committee until such a time that we are able to have someone step into the position of Chair. I believe that my service record in the Lane County Area and on this committee speaks to my integrity in service, including any financial issues in regard to the PR Committee. I have been and will continue to make myself available for this type of service and relationship with our community as a member of NA.

The PR Committee is based on many of the concepts contained in our 11<sup>th</sup> Tradition “Our public relations policy is based on attraction rather than promotion: we need always maintain personal anonymity at the level of press, radio, and films”. The fact that we have this type of policy, “implies the importance of a public relations “program” in carrying out our fellowships primary purpose” (It Works, pg. 203). Further, “Narcotics Anonymous is not a secret society; Tradition Eleven speaks to personal anonymity, not fellowship anonymity. The better known we are by the public, the more likely it is that addicts seeking recovery-or their friends, relatives, or co-workers will think of us and know where to find us when they decide to seek help” (It Works, pg. 204). For me, this means that we must be willing to maintain this type of connection between the fellowship itself and the community. I hope you will approve my request to remain the point of contact and accountability for the PR Committee.
