**ADHOC Bylaws Revision** – *Written Report:*

*Feb 2012*

*Greetings!*

*This is just a brief update. I have scheduled our first meeting for Feb. 12, 4:00p at my house. Anyone interested in the process of updating our guideline to be in line with Consensus Based Decisions are welcome to participate.*

*Unfortunately, there is still the issue of our capacity as an Area to update our banking situation. As you know, we have been looking at our options in regard to the potential of incorporation and registration of our name with the State. It was a while ago that I brought information on this topic, to this body. At that time, I indicated that our RSC was exploring options and that I would be following up as they met with a non-profit attorney, which I have done.*

*What does this have to do with our guidelines? Because we have continued, and will continue to have issues related to our banking...we are, in all likelihood, going need to take suggestion from the RSC example of how they format their guidelines/by-laws to be appropriate for use with incorporation; it goes without saying that we will be tailoring our guidelines/by-laws to the needs of the LCANA. It was the recommendation of the attorney that Incorporation would best serve the RSC, in terms of "protection for members, liability for our events, and doing banking in a post 9-11 world". (Thanks Cathy K. for that description) It is also a cheaper prospect in comparison Association. He also suggested a very specific format for writing guidelines/by-laws to be appropriate for the incorporation process... Cathy K. and/or Tom M. will be able to elaborate more on the issue.*

*I guess what I'm saying is that our re-development of guidelines will be a slow process that will take patience and commitment. I'll update this body as we move forward on this process.*
