**REGIONAL COMMITTEE MEMBER (RCM)**

Good morning,

Once again I work until midnight on Friday and will not make the executive committee meeting. But then, no one asked how it worked for me, so there you go.

I attended the regional conference in Coos Bay. It was very pleasant and productive. Thank you to the 2 or 3 Lane County area GSRs that were there for the GSR assembly. Your commitment to your position is awesome and I hope you will mentor others, especially those that are replacing you when you step down.

The big discussions at region were centered on CBDM as the region has not yet adopted any bylaw changes and the bylaws are suspended. We are doing business in the “spirit” of the previous bylaws, using CBDM to the best of our ability. The other big discussion was about the budget, which is due to be voted on in July. The regional executive committee will meet before the next quarterly meeting to discuss these matters and bring back a report. I plan on attending as Cathy K is hosting here in town. Our regional delegate has offered to do workshops in the next few months on money flow and I will work with activities or other committees interested in fundraising to see if we want to host an event. One of the ideas that were discussed was the idea of proposing a budget based on need and we asked the executive committee to give us a prioritized list of funding cuts that would be made if we don’t meet our income projections. There were several money flows that had not been accounted for in this cycle, such as split from the PNW in Seattle that would make adjusting our budget downward unnecessary at this time, but could not yet be accounted for as “real” income. It confuses me usually, so don’t sweat it if you don’t get it. I trust the process and we are watching the money very closely.

Regional elections are coming. Nominations will be open at the April regional with elections in July. Of note, the Alt Regional delegate position is coming open. It is a 3 year position, which translates into a 6 year commitment. There is travel around the state and otherwise, plus the World Service conference every 2 years. It is a funded position, but like all such positions, not fully. Requires extensive time and financial commitments. Rewards are good I hear in terms of fellowship and education.

**ARTICLE VII: ELECTIONS**

**A. ELECTED OFFICERS shall consist of:**

1. Chairperson
2. Vice Chairperson
3. Secretary
4. Alternate Secretary
5. Treasurer
6. Alternate Treasurer
7. Regional Committee Member
8. Alternate Regional Committee Member

**B. ELECTED SUBCOMMITTEE CHAIRPERSONS**

1. There is a required minimum of 2 years clean time (See article VII, Section D, # 4)
2. For duties of Subcommittee Chairpersons see each Subcommittee's Guidelines.
  - a) Hospitals and Institutions' Chairperson
  - b) Literature Chairperson
  - c) Activities Chairperson
  - d) Public Relations Chairperson
  - e) Directories Chairperson
  - f) Ad-Hoc Committee Chairperson(s)

**C. EXECUTIVE COMMITTEE**

1. The Officers and Subcommittee Chairpersons shall be referred to as the Executive Committee.
2. These members of the Executive Committee shall be elected annually in the month of April. Current GSR's shall make the nominations according to their group's conscience. Any participant other than a GSR may make a nomination and shall require the second of a GSR.
3. The term of office shall be one year.
4. No individual shall serve more than two consecutive terms in the same position.
5. No individual shall hold more than one LCASC position simultaneously.

**D. QUALIFICATIONS OF THE OFFICERS AND SUBCOMMITTEE CHAIRPERSONS:**

1. Will have the willingness and desire to carry out the duties of the office.
2. Will acknowledge that the duties shall be carried out in accordance with the Twelve Steps, Twelve Traditions and Twelve Concepts.
3. Have the willingness to give the time and resources necessary to do the job.
4. The required clean time may be waived by a 2/3 majority vote of the GSR's present at the time of nomination.

**E. SCHEDULING OF ELECTION PROCESS:**

1. January: Give out a list of positions, duties and qualifications. Also send out nomination forms, all to be taken back to the groups by the GSR's.
2. February: Any nomination forms that are complete shall be turned in to the Secretary. Any paper containing all of the information which appears on the nomination form will constitute a nomination form. The Secretary will examine and announce all positions still void of nominations. All positions are still open for nomination with special focus on those voids of nominations.
3. March: Complete nomination forms are presented to LCASC. All nominations must be accompanied by a complete, signed, nomination form. At the time of nomination, the form is read aloud and the nominees present can answer any questions from the floor regarding qualifications. If a nominee is unable to attend the meeting, a completed nomination form is acceptable. Any position that does not have a nomination will become an interim position. Completed nomination forms are included in the minutes.
4. The Officers and Subcommittee Chairpersons shall be elected in the month of April at the annual meeting. They shall be elected by a majority vote of the GSR's attending the meeting. The vote will be taken by written ballot. Ballots are to be prepared by the Secretary. Completed ballots will be collected by Vice-Chair or RCM and counted by (2) non-voting members of the LCASC. The tally will not be announced or printed in the minutes. The results will be read by the LCASC Chairperson. Newly elected officers and subcommittee chairperson begin duties at the end of the April LCASC meeting.
